This space rental agreement is between the Hall County Agricultural Society (hereinafter referred to as HCAS ) and the above EXHIBITOR.

1. Exhibitor agrees to pay \$110.00 for 1 booth for the period of July 14 to July 17. Each additional space is \$100.00. Full payment is to be received by July 5. No exhibit will be admitted to any space until rental for that space has been paid in full. There will be no refunds on cancellations after July 8.
2. The HCAS agrees to furnish one 10'X10' space. The HCAS electrician will hook up the power supply. The HCAS will furnish a standard 8' backdrop and 3' wings. Table and chairs are NOT furnished with your booth. You may bring your own or rent from the rental company that sets up the booths. (Midwest Tent & Events, phone #402-261-6784) Order form enclosed or on the web site.
3. Exhibitor set up Thursday, July 14 from 8:00 am to opening time 4:00 pm. Exhibitor may move out after closing Sunday July 17 or Monday July 18 from 9:00 am to noon.
4. Exhibitor agrees to have the booth open and ready for business on Thursday from 4:00 pm to 9:00 pm. On Friday and Saturday from 10:00 to 9:00 pm and Sunday from 12:00 to 4:00 pm.
5. Enclosed is an insurance waiver that **MUST** be signed and returned with your contract in order to reserve your booth area.
6. If you are using helium tanks in your booth, the helium tank must sit in a base so that the tank cannot tip over. Base to be supplied by exhibitor.
7. Exhibitor assumes sole responsibility for the cleanliness and maintenance of their area.
8. The HCAS assumes responsibility for the cleanliness and maintenance of buildings and common areas.
9. All locations for booth rentals will be determined by the HCAS management.

10. The vendor parking (and if you have a trailer for your products), must be parked in the designated area.
